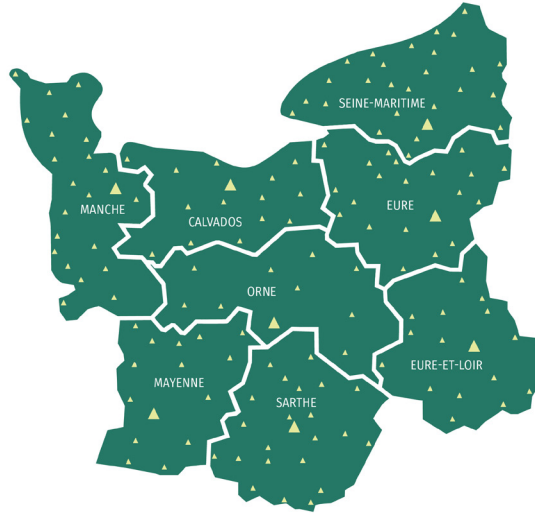

A CUSTOM CONTRACT FOR UNFORESEEN EVENTS

Booking the campsite, preparing the suitcase, checking the car : going on vacation requires good organization. However, sometimes we have to face unexpected situations. It is for this reason that Groupama offers you its trip cancellation insurance.

Reasons for intervention


- GROUPAMA ensures the reimbursement of the sums paid to the campsite in the event of cancellation for the following reasons :
 - A** → Serious non-contagious illness, injury or death of yourself, your wife or your partner, or your parents or descendants, son-in-law or other persons mentioned in the rental agreement.
 - B** → If you have to cancel or to renounce to your trip in the 48 hours before or after the contractual date when the rent begins, because of the interdiction of living in the campsite in case of pollution.
 - C** → Impossibility of taking possession of the rented accomodation as theresult of yourself, your wife or your partner employment lay-off or transfer.
 - D** → Impossibility of reaching the rented accomodation by car or by train the day planned to get the accomodation and in the following 48 hours, as the result of strikes or road blocks that prevent trac. These events must be testified by the mayor or any other qualied authority in the city of the place of holiday.
 - E** → Disaster leading to damage that happens before you leave home or a company you own, and that requires your presence on the damaged place the day of your leaving.
 - F** → Extension for the rent for more than one week : For all the events stated above in paragraph A, and that lead to a break of stay for more than 2/3 days of the initially planned of the rent, the amount of the compensation «cancellation» will be calculated in proportion of the remaining time of your stay between the day you leave the campsite and the end planned in the contract.

An uncompleted week is counted as a whole week

- The amount of the guarantees is limited to the price indicated on the rental or reservation contract.
- GROUPAMA does not insure the damages that are directly or indirecly linked to :
 - The consequences resulting from a contagious disease, an epimedic, a pandemic an enzootic an / or an epizootic
 - Deliberates acts of fraud made by yourself (owner or tenant)
 - A foreign or civil war (the insurance company has to given evidence that the loss is the result of a civil war)
 - All the effects linked to an explosion, a heat relaese, irradiations due to transmutations of atomic nucleus ou radioactivity or losses due to the effects of radioactive contamination.

 Except in case of fortuitous disasters or in case of absolute necessity, you must inform the campsite in writing and supply all the useful documentary evidences within **the 5 days** that follow the date you know you will not be able to come to your rented accomodation. Then the administrator ot the campsite will send these documents to Groupama
